2021 Charitable Giving under the CARES ACT

You may still take advantage of the federal government's provisions for charitable giving in 2021.

Under the CARES ACT, for 2021 you can deduct cash donations to public charities up to 100% of adjusted gross income (AGI) instead of only 60%. If you are making a gift to Altenheim next year, you may want to consider making the gift in 2021, to take advantage of this opportunity.

Required minimum distributions from IRAs and other retirement accounts resume. If you are 70 1/2 or older, you can make an IRA rollover or gualified charitable distribution to Altenheim to potentially lessen tax consequences with required distributions.

Taxpayers who take the standard deduction can claim a \$300 "above the line" deduction for cash gifts to public charities. For 2021 the above the line deduction has been increased to \$600 for married couples filing jointly.
